## **Membership Notes**

1. All memberships are due 31st December in each year.
2. **Pro Rata discount fee structure applies to New Members only (Not renewals of existing Memberships):** At 1st April 75% of full year subscription, 1st July 50% of full year subscription, 1st October 25% of full year subscription.
3. Any person joining the Association after 1st November in any year shall have and hold the rights, benefits and privileges of membership until and including 31st December of the following year.

### **Ordinary Membership**

Members must be financial to register, transfer or lease dogs, enter and exhibit at any exhibition. Ordinary Members are entitled to conduct business with the Association on all matters pertaining to the breeding/exhibiting of dogs. All Affiliate Club Executive Office Bearers must be Ordinary Members of the Association to hold office.

### **Kennel Membership**

One or more people involved in having a registered kennel name, and who have a current membership having paid the fee that equates to a single membership for one person, a double membership for two people and half a double membership for each subsequent individual beyond two.

### **Associate Membership (Affiliate Club Committee use only)**

All Ordinary Committee Members of Affiliated Clubs must be either financial Ordinary or Associate members of the S.A. Canine Association Inc to hold office. Executive Committee members must hold a full financial membership.

I am aware that acceptance of my application will entitle me to be an ordinary Committee Member of an Affiliated Club and entitle me to participate in all activities of an Affiliated Club other than those conditions listed below.

Associate Membership does **NOT** entitle the member to the following:

- To receive the monthly SA Canine Journal.
- Vote at any meeting of the Association.
- Be elected to or appointed to any office in the Association.
- Enter or handle any dog in any exhibition approved by the SA Canine Association.
- Register a Kennel Prefix or apply for the registration of any puppies bred.

Should an Associate Member wish to join as a FULL Member during the course of the Associate Membership's duration, the Associate Membership fee will be deducted from the full membership fee.

### **Junior Membership (Under the age of 18 years)**

- Register a Kennel Prefix or apply for registration of any puppies bred.
