**Vetting Time:** Both Days Obedience 8.00am – 8.30am & Rally 11.30am – 11.45am. Bitches without desexing paperwork only. All dogs must pass through checkpoints by close of vetting. Dogs vetted for Obedience are not required to be again for Rally.

**Entry Fees:** \$12.00 per entry (1 class per entry form).

**Order of Judging:** As per catalogue. All rings simultaneously except:

Obedience: UDX followed by CCD, Rally : Ring 1: Novice then Excellent Ring 2: Master then Advanced

**TROPHIES:** Prizes for 1<sup>st</sup> place in each class each day (qualifying only). Trophies for State Champions for each class will be presented at the conclusion of all judging on Sunday.
